8	Each school must have access to "an" emergency asthma kit	Minimum of one kit per school, but with consideration of school size and time taken to retrieve it a second or third kit may be recommended. Opt in / Opt out consent must be obtained from parents for children in school who have a salbutamol inhaler.
